**1. Premier League Panel rulings**

Deduct one point from HKFC-B for late verification in W2513.

Deduct two points from CELBC-A for one playing wearing improper shoes in M2662. The Disciplinary panel has upheld the panel ruling on CELBC appeal.

Deduct one point from HKJC-A for late verification in M2761.

Deduct two points from SBSC-B for change player after the draw in W2833. Add two points to HKCC-A for their lost to defaulting team.

Deduct 4 points from VLBC-C for failure to arrive in M3052.

Due to ferry collision accident on 1-Oct, five outstanding HEGSC home games were rescheduled and played in neutral green. One game swapped the green. All matches were completed on league schedules.

**4. Triples League 2012**

League fixture v2 issued on 13 Oct. Green booking and game re-arrangement are in progress. All rescheduled games have to be fixed before 1-Dec.

In current fixture, the home and away ratio is limited within 1 game. If both sides mutually agree to swap, the League Panel proposed it to be limited within 2 games. That is after the swap, the difference of both sides in home and away games should be within 2.

KBGC withdrew their women C side. Sides will get a bye when playing against them.

HEGSC will use ALC as their home green before Jan 2013 and the affected games have to be rescheduled.

Due to IE close for maintenance until 19 Jan 2013, the league panel recommended GBLBC to use Victoria Park as their home green before 19 Jan. Same as HEGSC, all affected games have to be rescheduled.

A fixture v3 will be issued to reflect the above changes.

## **Report on Sime Darby Asia Pacific Merdeka Indoor Bowls Championships 2012**

### **1. Introduction**

This event was hosted by Malaysia Lawn Bowls Federation (MLBF) at Bayuemas Indoor Bowls Stadium, Kuala Lumpur, Selangor, Malaysia. The host was supported by a sponsor who kindly provided hotel accommodation, breakfast and lunch, and the costs of each represented country's players and managers.

### **2. The Team**

The Hong Kong team comprised of the winners of the 2011 Indoor Singles Competitions who were Tony Cheung, Walter Kwok, Vivian Yip and Queenie Lai. Practice sessions were held in August and September in HKFC indoor greens and Island East indoor greens in preparation for the competition.

### **3. Format of Play**

The playing format was a round robin in four sections and the top three in each section will proceed to the Top 12, Quarter Finals, Semi-Finals and Finals.

a) Singles consisted of 21 shots with each player playing 4 bowls.

b) Mixed-pairs consisted of 15 ends with each player playing 3 bowls.

c) Mixed-fours consisted of 15 ends with each player playing 2 bowls.

### **4. The Competitions**

There were 15 participating countries and regions including Australia, Brunei, China, Fiji, Hong Kong, India, Japan, Macau, New Zealand, Philippines, Singapore, Sri Lanka, Thailand and Malaysia. Pakistan did not participate the matches.

### **5. The Results**

Vivian Yip proceeded to the Quarter Finals. Tony Cheung proceeded to the Top 12 play-offs. The Mixed-fours also proceeded to the Top 12 play-offs. Please refer to the attached for more details on the overall results.

## 6. Dope Test

A dope test was performed on selected players. Vivian Yip was selected and underwent the test.

## 7. Dress Code

The players were requested by the organizers to be dressed in clothes other than those used for competitions when attending the Welcome Dinner. Players taking part in this event next year should take notice of this requirement.

## 8. Performance of Players

All players performed well in the matches.

## 9. Look Forward

At the closing ceremony, Tun Ahmad Sarji Bin Abdul Hamid, President of the Bowls Asia and MLBF announced that more top players will be invited to take part in the competition next year.

Dear Convenors,

You may have been fully aware of the decision made by Discipline Panel about deducting CELBC two points towards the league result.

Before I explain CELBC's stance, I would like to illustrate the facts briefly. On 23.9.2012, CELBC-A played a Premier League Division 6 game against CPLBC-A at Siu Lek Yuen Playground. During the match, no CELBC player noticed that one of our players wore a pair of improper shoes. On the other hand, no CPLBC-A player raised the query about the shoes during the game.

After the game, CPLBC-A sent a photo to League Panel, asked if the player's shoes were proper. Then Legal Panel requested CELBC to clarify. CELBC replied promptly, admitted the mistake, i.e. the player did bring a pair of lawn bowl shoes but he forgot to change them.

Finally Legal Panel decided to deduct two points from CLEBC-A towards the league result. Though CELBC lodged an appeal to the Discipline Panel, Discipline Panel upheld League Panel's decision.

Now, CELBC decides not to pursue further to the Appeal Panel, even though it opines that the penalty is excessive. However I would like to quote the comments from the Chairman of the Discipline Panel:

**The incident should be and could be resolved amicably if parties concerned have more respect to the game and treasure sportsmanship above other things. A friendly reminder could achieve the goal of fairness and good sportsmanship. The actions taken by CPLBC can be more tactful and considerate.**

I have no intention to speculate the motive of CPLBC not to raise the doubt during the game. However CELBC would like to add one point: "All lawn bowl matters should as far as possible be resolved at the spot". I trust that all players are willing to rectify the mistakes they commit unintentionally. As the President mentioned, we should always treasure a good sportsmanship in lawn bowls and CELBC undertakes to continue to develop in this direction. Thank you.
