1 ACCEPTANCE OF PREVIOUS MINUTES

Having been circulated to all members of the Council of Management, the minutes of the council meeting held on 8 November, 2021 were taken as read, confirmed, and approved.

2 <u>MATTERS ARISING</u>

- 2.1 The Chairman welcomed the new convenor of KCC, Mr. Bob Mehta.
- The Honorary Secretary reported that quality of the windbreaker sample provided by the selected supplier for the 60th anniversary was poor and unacceptable. Therefore, the Procurement Panel decided to carry out another procurement exercise by adopting the "restricted open tendering" method in order to speed up the process. To this end, all member clubs were requested to provide their suppliers' contacts to us and our staff would also solicit other suppliers for as many as possible from other NSAs and from the websites. Thereafter, we would send invitation to all of them for tendering. An ad hoc tendering board would then be established to complete the whole procurement process. There being no objection from the floor, the above procurement arrangement for windbreaker was endorsed.

3 CORRESPONDENCE

3.1 We received an application for membership from a new club Bowling Friends Club. There being no objection from the floor, the application was approved by the Council.

4 TREASURER'S REPORT

4.1 On behalf of the Hon. Treasurer, the President presented on table the summary of outstanding payments as at 13 December, 2021. The President appreciated the cooperation of all members for keeping our financial status healthy.

5 NATIONAL LEAGUE

5.1 <u>Premier League 2021</u>

Result of the Premier League 2021 had been finalized and was presented on the website. We congratulated the winners and advised members that the scorecards could be discarded.

52 <u>Booking of Public Greens</u>

Some managers of the LCSD public greens enforced their policy that reservation for league games must be made three months in advance. Thus, the league fixture would require to be issued three months before commencing the game. With a view to extending the reservation time frame, we would discuss further with LCSD on the arrangement. If negotiations with LCSD failed, enrolment for league games would be open four months before commencing the game.

9 <u>INTERNATIONAL</u>

9.1 VP (International) reported that a member of the Hong Kong Squad quitted due to personal reason.

10 <u>DISCIPLINARY PANEL</u>

- 10.1 The investigation of Mr. Jacky Wong and the Lawn Bowls Training Centre relating to an alleged violation of the Bye-law on misconduct was still on-going. The lead investigator of the investigation team requested an extension for one month in submitting their report, which was originally scheduled for 30 November, 2021, due to complexity of the case and the volume of documents to be studied. Members of the Council would be updated in due course.
- As regards the litigation filed by Ms. Vivian YIP of the CCC, the court had preliminarily scheduled a one-day Pre-trail Review in June and six-day Trial in August 2022. The legal expenditure so far was \$210,000 out of an approved funding of \$250,000. In anticipation of further requirement on legal expenses, the Chairman would solicit additional funding from the Council after consulting the legal advisor on fees.

11 HONG KONG INTERNATIONAL BOWLS CLASSIC & CLASSIC CARNIVAL2022

11.1 We would keep in view of the Hong Kong International Bowls Classic & Classic Carnival 2022 due to uncertainties of the COVID-19 pandemic. Should the Classics be cancelled, we would likely organize a local or regional event instead.

12 ANY OTHER BUSINESS

- 12.1 The nomination of members for various panels had been sent to Councilors for consideration. There being no objection from the floor, the nominations were approved by the Council.
- 122 VP (Technical) reported that another update of the Bye-laws was in progress. Details of which would be updated in next meeting.
