Having been circulated to all members of the Council of Management, the minutes of the council meeting held on 3 June 2024 were taken as read, confirmed, and approved.

# 3 <u>CORRESPONDENCE</u>

ILBC Fun Day was postponed to 3<sup>rd</sup> August, 2024.

HKFC requested to hold Mike Worth Memorial Cup on 11<sup>th</sup> October, 2024. The second event was Hong Kong Football Club Open which would hold between 6<sup>th</sup> and 9<sup>th</sup> March, 2025.

KCC Mixed Fours Invitation changed to club internal competition.

YLLBC would hold Triples Invitation at Mei Foo Indoor Green on 24th and 29th March, 2025.

The Hong Kong Buddhist Association would hold competition between 14<sup>th</sup> and 25<sup>th</sup> October, 2024.

There being no objection from councilors, the above competitions were approved.

### 4 TREASURER'S REPORT

- 4.1 The summary of outstanding payments was tabled to all councillors. The Hon. Treasurer reported that there were two clubs with overdue 90 days payment and only one overdue 120 days payments.

### 5 NATIONAL LEAGUE

VP (National League) reported the following:

# 5.1 Premier League 2024

Premier League 2024 was still processing.

#### 52 Six rinks in VP would be closed for maintenance

Six rinks in VP would be closed for maintenance from September to December 2024. The schedule of 11 matches was revised. The update fixture has been uploaded at website.

# 53 Standard template to generate league fixture

VP (National League) proposed to use standard template for future league fixture

generation. The system was open and fair, it avoided unnecessary speculations or arguments.

Convenors can provide their feedback and improvements before 7<sup>th</sup> August. The new system would be used in next Triples League.

# 5.4 Triple League 2024

Triple League open for entry and deadline was on 8<sup>th</sup> August, 2024. LBA would finalize the fixture to enable clubs to submit booking form to LCSD in August. Triple League would start on 14<sup>th</sup> December, 2024. VP (National League) reported that ALC would be under maintenance for whole Triple League period.

2024 National Championships Finals Day – Summer was rescheduled to  $18^{th}$  August 2024 (Sun) at HKFC. Fixture was released for reference.

# 7 <u>DEVELOPMENT</u>

- 7.1 We conducted soft bowls trial week at St. Joseph's Primary School on 25<sup>th</sup> and 26<sup>th</sup> June, 2024 for introducing lawn bowls sport to P4-5 students.
- 7.2 The finals of Under 25 Indoor Pairs Competition 2024 was completed on 21st July, 2024 at ALC. There were 28 teams participated.
- 7.3 The entry of Under 25 Age Group Lawn Bowls Championship 2024 would be closed this Wednesday on 24<sup>th</sup> July, 2024.

### 8 TECHNICAL

VP (Technical) reported the following:

8.1 The written examination of umpire training course finished. The second-round examination would hold this Friday on 26<sup>th</sup> July, 2024. After written examination passed, candidates would under practical examination in August.

### 9 **INTERNATIONAL**

- 9.1 The Hong Kong International Bowls Classic 2024 singles qualifying finished. Overseas teams confirmed their participation.
- 9.2 2024 World Bowls Junior Indoor Championships would hold at HKFC and CCC for 6 days in December. 20 countries would send one boy and one girl for singles and mixed pairs event.

# 10 <u>DISCIPLINARY PANEL</u>

Regarding the case between WISC and VLBC, Disciplinary Panel defined it as a misunderstanding. LBA would close the case.

### 11 HONG KONG INTERNATIONAL BOWLS CLASSIC 2024

Local teams have been confirmed. LBA would announce the fixture later.

### 12 **ANY OTHER BUSINESS**

- 12.1 LBA received club application namely SBI-Lawn Bowls Alumni Limited. There were 30 men and 30 women members at the club. They would use Yuen Chau Kwok as home green. There being no objection, the above club application was approved.
- 12.2 Mr. Edward Pang informed that internal monitoring team aimed to enhance corporate governance. They would focus the areas relating integrity, procurement, coach and umpire management and selection of squad representatives within six months. Convenor suggested to add members to the team.
- 12.3 Regarding the legal case, legal fee was under processing. The impact was over two million at this moment. VP(Technical) said that we would report next time.
